### Comments:

Item 5, (The Nomination of Committee Officers). No nominations received for Safety Officer. SWEFTA is asking every club to take on this role for their Home event after the Home club knows its own hazards best.

Item 6, (New Bench Rest Secretary). The item was agreed in principle but no nominations received. Unfortunately this means SWEFTA will not be organising a Bench Rest league in 2021.

Item 7, (Revised Shoot Fees). £5 to SWEFTA and £5 per event entered is a major increase on previous years, some shooters have been furlowed or have received no income during the 2020 Covid pandemic. Perhaps SWEFTA should consider reducing the fees.

Item 9, (Event Management). This should be undertaken by the Home club until the Pandemic restrictions are lifted fully on or about the 21<sup>st</sup> June 2021 and then revert back to pre-Covid procedures.

The items voted "FOR" by the association come into effect on the 1<sup>st</sup> May 2021.
